9. Director's Report

Ms. Quinn reported on the following:

<u>JBJ Soul Foundation</u>: Item A under New Business is an extension to the short-term lease with Jon Bon Jovi Soul Foundation for the utilization of the library café for a pop-up café to Friday, May 23, 2025. The café opened in mid-February and the extension would give their operations a full three (3) month trial run.

African American Culture Connection: Last Friday I attended the African American Culture Connection at the Monroe Township Library. The event was created by MentorNJ's African American Meet-up Group and EDI-NJ and co-sponsored by the New Jersey Library Association and LibraryLinkNJ. The conference featured several speakers who were specialists in their fields. The conference was coordinated by OCL Librarian Muriel Odrick, who did an outstanding job and one of the featured speakers was OCL's Training Officer Deborah Blackwell.

Institute of Museum and Library Services (IMLS): A Presidential Executive Order dated March 14, 2025, on Continuing Reduction of the Federal Bureaucracy that directs agency heads at several federal agencies, including the Institute of Museum and Library Services (IMLS), to submit a report within seven (7) days to the Director of the Office of Management and Budget confirming which components or functions of the agency are statutorily required and to what extent.

The American Library Association and EveryLibrary, a 501c4 advocacy organization for libraries, Publishers Weekly, and the Chief Officers of State Library Agencies (COSLA) released statements and are provided for your review.

According to public documents, in 2024 the New Jersey State Library received over \$4.5 million in funding from the IMLS. The NJ State Library services that Ocean County Library uses the most are: 1) statewide databases and e-resources, 2) statewide interlibrary loan, 3) technology infrastructure, and 4) Talking Book and Braille Center (TBBC).

- JerseyConnect Statewide Technology Program: brings technology services and infrastructure to public libraries across the state by providing internet access and related services to public libraries such as web hosting, email hosting and management, email spam and virus filtering, cloud storage, domain name hosting, Wi-Fi management, and consultation on technology projects.
- NJ State Library's Talking Book and Braille Services (TBBC). As a Deposit Library of TBBC, OCL provides services to Ocean County residents who are blind, visually impaired, dyslexic, unable to hold a book, or print disabled. This service is especially important for Ocean County's senior citizens.

We need to wait to hear more news on the federal front.

Public Relations to present on the return of the 100-year-old book: Sherri Taliercio, Librarian 4, Public Information Officer and Tom Mongelli, Public Relations presented the Library Commission with a story of a book that was returned after ninety-nine (99) years. Mary Cooper of Toms River returned a book that was checked out by her grandfather, Captain Charles Tilton (1884-1927). The story caught on with multiple media outlets included those overseas.
