Overview:

The Parent Permission Waiver must be signed for your teen to be able to apply for school-year volunteer opportunities via <u>Galaxy Digital</u>.

Note: There are two ways the Parent or Guardian can sign the waiver. Full Waiver directions below.

<u>The quickest way</u> is to go through the teen volunteers Galaxy inbox with your teen. The link with electronic signable waiver will appear. The Parent or Guardian can sign it there, directly in Galaxy.

<u>The second way</u> is for the Parent or Guardian to find the link in their email. If there is nothing from <**OCL** Volunteer Services <u>no-reply@galaxydigital.com</u> > in your personal Inbox, you should be sure to check your Spam Folder.
